## SCHOOLING DAYS

Schooling days at Grass Ridge Farm are available year round for registered instructors and their students. Reservations for schooling days are accepted from instructors who have registered with GREF. A registered instructor must accompany all riders schooling at Grass Ridge Farm. Instructors who want to school and/or ride at Grass Ridge Farm must comply with the rider registration process. The Instructor is responsible for ensuring each rider schooling at Grass Ridge Farm is registered with GREF and, prior to schooling, each rider has signed a waiver and submitted all membership, schooling, stall rental, and camping fees.

## SCHOOLING REQUIREMENTS

Prior to schooling at Grass Ridge Farm:

- 1. INSTRUCTOR REGISTRATION** - The instructor must submit an ***Instructor Registration form*** to GREF.
- 2. RIDER REGISTRATION** - Every rider must be a member of GREF. To become a GREF member, a rider must (A) complete an ***Annual Member Form*** and pay membership dues to GREF, and (B) complete a ***Waiver*** to be submitted to GREF by the rider's instructor.
- 3. INSTRUCTOR RESERVATION REQUEST** - Registered instructors may submit an ***Instructor Schooling Reservation Request*** to GREF to schedule a schooling date.

# GRASS RIDGE EQUESTRIAN FOUNDATION RULES

GRASS RIDGE EQUESTRIAN FOUNDATION (GREF) REQUIRES ALL VISITORS, INSTRUCTORS, RIDERS, DRIVERS AND GUESTS COMPLY WITH THE FOLLOWING RULES:

- All Riders And Drivers Must Be A Member Of GREF
- All Instructors, Riders, And Drivers Must Have Completed The Registration Process, Signed A Waiver And Paid All Applicable Fees
- Helmets And Protective Gear Are Required And Must Comply With U.S. Eventing Association Safety Regulations
- All Drivers Must Wear Safety Helmets, Carry A Whip and Breeching Is Required For Carts Without Brakes
- Enter At Your Own Risk – Beware Of And Avoid Wildlife
- Obey All Posted Signs and Printed GREF Rules and Map
- No Smoking At Any Time
- No Open Fires (Barbeques Are Allowed In Camping Area Only)
- Park In Designated Parking Areas Only
- Camping: Back In Parking In Designated Camping Area Only
- Motorized Vehicles Must Be Operated By A Licensed Driver
- All Pedestrians And Vehicles (motorized and non motorized) Must Stay On Mowed Trails, Roads, And Mowed Areas
- Off Limits: Private Residences & Barns
- Dogs Must Be On A Leash At All Times
- No Horse Trailer Cleanout or Dumping

# WAIVER & RELEASE OF LIABILITY

## This document waives important legal rights, read it carefully before signing.

In consideration for, and as condition of, allowing the undersigned access to and the use of the grounds and facilities on the property commonly known as Grass Ridge Farm, 197 Curly Horse Ranch Road, Sonoita, Arizona 85637, Redtail Ranch 193 Curly Horse Ranch Road, Sonoita, Arizona 85637, in Santa Cruz, County, Arizona (collectively referred to as the "Property"), the undersigned agrees as follows:

1. I understand that riding, driving, jumping, schooling, training, showing and eventing, is a high risk sport and that my participation in these activities is voluntary and may also involve participation in an "equine activity" as defined by applicable laws and is wholly at my own risk.

2. I expressly agree to assume all risks, known and unknown, associated with the use of the Property, for equine activity or otherwise, dangers and conditions which are an integral part of equine activity, including, but not limiting to, the propensity of equines to behave in ways which may result in injury, harm or even death to humans or other animals around or near them, hazards related to surface and subsurface conditions, collisions with other equines or objects, and the potential of a participant to act in a negligent or unskilled manner which may contribute to injury to the participant or others, including failure or inability to maintain control of the animal.

3. I understand that owners of the Property and Grass Ridge Equestrian Foundation make no warranty or representation regarding the condition or suitability of the Property for riding, driving, jumping, schooling, training, showing, eventing, and equine activity, or any other use.

4. I agree to release, defend, indemnify, protect and hold harmless the owners of the Property and Grass Ridge Equestrian Foundation, their directors, officers and members, employees, agents, volunteers, invitees and guests from and against any and all liability for death or injury or illness to person or damage to property, including horse(s) I may own or ride, claims, demands, actions, causes of action, liability, damages, losses, costs and expenses, including reasonable attorneys' fees and costs of litigation, arising out of, or in connection with, the use of the Property and facilities thereon.

5. I agree to observe and obey all instructions, rules and regulations for the use of the Property, including all posted signs. I agree to keep, maintain in good order and use all required safety equipment.

6. I warrant and represent that I am over the age of 18, or if signing for a minor I am the legal guardian, I have read and understand this Release, and I sign this Release knowingly and freely.
